




1. How has the COVID-19 pandemic personally impacted you or your household? Select all that apply:




2. Describe your workplace.




3. If applicable, what industry do you work in?




4. If applicable, what is your role at your place of work?




5. How has the pandemic impacted your workplace? Select all that apply:




















ii. Which of the following best describes you?




iii. Gender




iv. City of Residence




v. Primary Language Spoke at Home






