**THIS DEED**, executed this \_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by **LEE COUNTY, FLORIDA**, A POLITICAL SUBDIVISION OF THE STATE OF FLORIDA, whose address is Post Office Box 398, Fort Myers, Florida 33902-0398, COUNTY, to **Habitat for Humanity of Lee and Hendry Counties, Inc.**, a Florida non-profit corporation, whose address is 1228 North Tamiami Trail, North Fort Myers, FL 33903, Grantee.

**WITNESSETH:** The COUNTY, for and in consideration of the sum of Ten (\$10.00) Dollars to it in hand paid by the Grantee, receipt whereof is hereby acknowledged, has granted, bargained and sold to the Grantee, its heirs and assigns forever, the following described land, lying and being in Lee County, Florida:

This grant conveys only the interest of the County and its Board of County Commissioners in the property herein described, and does not warrant the title or represent any state of facts concerning the title.

If the property conveyed herein is not used for the construction of affordable housing within five years, then title to this property will automatically revert back to Lee County. Affordable housing is defined as a dwelling unit made available to a household that is comprised of one or more persons determined by Lee County to be of very low, low, moderate or work force income according to HUD's households income limits adjusted for household size.

**LEGAL DESCRIPTION**
