- a) Owner will grant said easement to County for the sum of \$7,000.00, inclusive of land, improvements and cost to cure; County to pay recording costs and title insurance fees.
- b) The purchase price is mutually agreeable to both the Owner and County and represents the voluntary sale and purchase of the temporary construction easement interest in the property in lieu of County's condemnation.

- d) County will pay Owner the amount agreed upon in item (a) of this agreement in U.S. Currency by Automated Clearing House (ACH) transfer within 90 days of the execution and acceptance of this Easement Purchase Agreement and the Temporary Easement by County.
- e) Owner agrees that County, its successors and assigns will be allowed to use said Easement Area as specified in the Temporary Easement.

County will pay reasonable lender processing fees and costs associated with obtaining releases of mortgage, not to exceed \$1,000 per release.
- h) This voluntary sale and purchase is considered by Florida law to be exempt from the payment of Documentary Stamp Taxes because this transaction was made under the threat of eminent domain by the County.

THIS AGREEMENT ("Agreement") is made and entered into this _____ day of _____, 202___, between Six Lakes Country Club, Inc., a Florida Corporation, whose address is 9151 Littleton Road, North Fort Myers, Florida 33903 (hereinafter referred to as "*Grantor*"), and Lee County, a political subdivision of the State of Florida, whose address is Post Office Box 398, Fort Myers, Florida 33902-0398 (hereinafter referred to as "*County*").

Grantor is the owner of the lands described in attached Exhibit "X", and as such has the power to grant County a temporary interest in these lands (hereinafter the "Temporary Construction Easement Area").

Grantor, for good and valuable consideration, receipt of which is hereby acknowledged, does hereby grant to the County, permission to enter upon the Temporary Construction Easement Area for the purpose of ingress and egress by workers, machinery, and vehicles, and for the purpose of staging, storing, and/or stockpiling materials and equipment within the Temporary Construction Easement Area as necessary to harmonize the driveway elevation, facilitate construction of a sidewalk, perform drainage and gravity wall improvements within the existing right-of-way, perform grading and restoration activities, and to facilitate removal and re-installation of any perimeter metal fencing and/or gates in conjunction with the Littleton Road Widening - Corbett Road to US 41, Project No. 5028.

County, including County officials, employees, and agents, have the right to enter upon the Temporary Construction Easement Area at reasonable times with the necessary equipment, personnel and vehicles in order to exercise the rights granted herein. I. MOTION REQUESTED

A) Authorize County Lands to make a binding offer to Six Lakes Country Club, Inc., a Florida Corporation, in the amount of \$7,000 to acquire a temporary construction easement interest in Parcels 350-A (TCE) (+/- 1,351 square feet), 350-B (TCE) (+/- 600 square feet) and 350-C (TCE) (+/- 418 square feet) for the Littleton Road Widening – Corbett Road to US 41, Project No. 5028 (formerly identified as 8414), pursuant to the terms and conditions of the Easement Purchase Agreement;

B) Authorize the Chair on behalf of the Board to execute the Easement Purchase Agreement and Temporary Construction Easement Agreement, should the offer be accepted;

C) Authorize payment of necessary fees and costs to complete the transaction, estimated to be \$1,500; and

D) Authonize County Lands to handle and accept all documentation necessary to complete the transaction.

II. ITEM SUMMARY

Approves an offer of \$7,000 to acquire a temporary construction easement interest in Parcels 350-A (TCE) (+/- 1,351 square feet), 350-B (TCE) (+/- 600 square feet) and 350-C (TCE) (+/- 418 square feet) for the Littleton Road Widening – Corbett Road to US 41, Project No. 5028. This offer is necessary to accommodate the construction schedule, should condemnation actions be required. The estimated cost to close this acquisition is \$1,500. The appraised value is \$5,500 (inclusive of land, improvements and cost to cure). The recommended increase of \$1,500 is to avoid condemnation and its costs and expenses.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

On February 21, 2017, Administrative Agenda Item A3, Blue Sheet No. 201700052, the Board approved an alignment study to analyze alternative alignments and determine the right-of-way needs for the future widening of Littleton Road.

On January 15, 2019, Consent Agenda Item 25, the Board approved a three-lane alternative, which includes two (2) 11foot travel lanes, one (1) 12-foot bi-directional lane, on-road bicycle lanes, and a 6-foot sidewalk on each side of Littleton Road.

The Resolution of Necessity (No. 21-05-34) for this parcel was adopted by the Board of County Commissioners on May 18, 2021 in Administrative Agenda Item 1.
