

LEE COUNTY, FLORIDA
EMERGENCY RESOLUTION NO. 23-10-22
EIGHTH EXTENSION OF STATE OF LOCAL EMERGENCY COUNTYWIDE

WHEREAS, the Florida Governor Ron DeSantis issued Executive Order 23-171 on August 26, 2023 (Attachment A) declaring a State of Emergency for 33 counties, including Lee County; and

WHEREAS, the Board of County Commissioners of Lee County, Florida declared a State of Local Emergency on August 28, 2023, in anticipation of the impacts of Tropical Storm/Hurricane Idalia, Emergency Resolution No. 23-09-02 (Attachment B), pursuant to Chapter 252, Florida Statutes, and Lee County Ordinance 87-01; on September 4, 2023, the State of Local Emergency was extended pursuant to Lee County Ordinance 87-01, Emergency Resolution No. 23-09-45 (Attachment C); on September 11, 2023, the State of Local Emergency was extended pursuant to Lee County Ordinance 87-01, Emergency Resolution No. 23-09-46 (Attachment D); on September 18, 2023, the State of Local Emergency was extended pursuant to Lee County Ordinance 87-01, Emergency Resolution No. 23-09-47 (Attachment E); on September 25, 2023, the State of Local Emergency was extended pursuant to Lee County Ordinance 87-01, Emergency Resolution No. 23-09-48 (Attachment F); on October 2, 2023, the State of Local Emergency was extended pursuant to Lee County Ordinance 87-01, Emergency Resolution No. 23-10-02 (Attachment G); on October 9, 2023, the State of Local Emergency was extended pursuant to Lee County Ordinance 87-01, Emergency Resolution No. 23-10-04 (Attachment H); on October 16, 2023, the State of Local Emergency was extended pursuant to Lee County Ordinance 87-01, Emergency Resolution No. 23-10-06 (Attachment I); and

WHEREAS, Florida Statutes Section 252.38(3)(a)(5) provides authority for political subdivisions to declare a State of Local Emergency and to waive the procedures and formalities otherwise required of political subdivisions in order to take whatever action is necessary to ensure the health, safety, and welfare of the community; and

WHEREAS, Chapter 252 of the Florida Statutes limits the duration of each State of Local Emergency to seven (7) days and it may be extended, as necessary, for additional terms in seven (7) day increments; and

WHEREAS, Hurricane Idalia has caused personal injury and extensive damage to commercial, residential and public structures of Lee County; and

NOW, THEREFORE, IT IS RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA this 23rd day of October, 2023:

1. That the effects of Hurricane Idalia continue to pose a serious threat to the lives and property of the residents of Lee County and that an extension of a State of Local Emergency is declared, effective immediately for all unincorporated and incorporated areas within the local boundaries of Lee County, Florida.
2. The Resolution No. 23-09-02 Declaring a State of Local Emergency is hereby extended for an additional seven (7) day increment.

BE IT FURTHER RESOLVED that the Board of County Commissioners hereby exercises its authority and waives the procedures and formalities required by law of a political subdivision, as authorized under §252.38, Florida Statutes.
