# Overview of County Roles

#### **PRE-CONVERSION**

- "An agreement between the system board and Lee County must be completed no later than 120 days after the date on which the public meeting is held to determine if conversion is in the best interests of Lee County residents."
  - HB 227 (2023)

#### **POST-CONVERSION**

- Monitoring
- Enforcement
- Lee County Local Provider Participation Fund

# Conversion Agreement

UNDER AMENDED ENABLING ACT



### **Primary Elements:**

- "An enforceable commitment that programs and services provided by Lee Memorial Health System will continue to be provided to residents of Lee County in perpetuity...[unless] otherwise agreed to...."
- Description of assets & liabilities to be transferred
- Estimated total value of assets to be transferred
- Total value of liabilities to be assumed
- Other terms mutually agreed to by Board of Directors and Board of **County Commissioners**

# **TIMELINE** 2 0 2 4

#### June 13

 Lee Health Board of Directors adopts resolution finding that "the best interests of Lee County residents are best served by Conversion."

#### **August 17**

 Draft Conversion Agreement published

#### **OPTION**

Publish proposed agreement NLT August 27

#### **October 1**

 BoCC considers Conversion Agreement

#### **OPTION**

BoCC Special Meeting 10/8 – 10/11

#### October 8

Call BoCC Special Meeting

# Lee County Local Provider Participation Fund

#### County Facilitates Direct Payment Program Participation

- Among other potential supplemental payments
- Funding to hospitals that provide services to Medicaid patients
  - Unlocks federal matching dollars to help address
     Medicaid shortfall

- County ordinance
- Voluntary provider assessment levied annually by County
- Florida Agency for Health Care Administration collects IGTs
- IGTs & State funds matched with federal funds to provide supplement



# LPPF Process

STEP 1

 Non-Governmental providers pay assessment to be deposited in a Local Provider Participation Fund (LPPF)

STEP 2



STEP 4


 Governmental entities send funds from LPPF to AHCA to support non-federal share of Directed Payment Program (DPP)

 AHCA sends Federal and Non-Federal funds to Managed Care Organization (MCO)

 MCO sends quarterly lump sum payments to hospitals based on utilization data
