

## **Growing Pressures & Threats**





#### **Top Takeaway:**

Significant pressures lead Lee Health to consider ways to stay strong and with local control to best serve our community

#### Health care faces significant pressures

- Dramatic and lasting cost increases for supplies and labor brought on by the pandemic
- Medicare/Medicaid reimbursement not keeping up with increased costs
- Many health systems operating at a loss
- A surge of disruptors, such as CVS, Amazon, and private equity companies
- Rise in consumerism
- Keeping pace with the velocity of technology/Al advancements
- Shift toward value-based care
- Physician/nurse burnout and shortages

## Why Evaluate Our Structure



**1916** 

Lee Health opens as a community-focused nonprofit

1968

Began operating as an independent special healthcare district created by the Florida Legislature and governed by an elected Board of Directors

**1970- Today** 

Decades of rapid growth in our communities

2019

Certificate of Need (CON) Repealed Halifax Hosp. vs. State - Florida Supreme Court decision limiting all independent special hospital district authority

2020-2022

65 new hospitals announced being built in Florida

2023

Recognizing the uphill climb of systems like ours, the Florida Legislature established a process and timeline to evaluate our structure



**Our commitment** to our safety-net mission, as well as continued local leadership and independence is unwavering. This commitment is also the driving factor in our decision to evaluate our structure.

## Legislative History/Public Policy Shift



#### **Lee Health Approach**

- (2020) HB 1301 Rep Rodrigues Sought to expand geographic boundary of the Lee Health special district
- (2021) HB 243 Rep Roach Sought to eliminate the border of the Lee Health special district
- (2022) HB 897/SB 1260 Rep Botana/ Senator Gruters – Permissive conversion authority for all public hospital districts \*Passed by the Legislature & vetoed by the Governor
- (2023) HB 227 (2023) Rep Botana -Permissive conversion authority for Lee Health \* Passed by the Legislature & Signed by the Governor

#### **Public Policy Shift**

- At one time more than 80 public hospital districts existed in Florida
- Today there are only 28 and many of those taxing districts no longer operate hospitals
- Legislature directed preferred public policy to achieve desired outcome
- Direction was based on historical precedent and desire to limit government while maintaining services for residents

## **Conversion Timeline**



Lee Health is adhering to a process mandated by the Florida State Legislature to determine whether converting to a community-focused nonprofit serves the best interest of the residents of Lee County. The timeline below outlines the steps in this process as set forth by the Legislature.

  - Board Compensation: Members of the successor NFP corporation's initial Board of Directors would be eligible for compensation in the same manner as currently provided in the Enabling Act (subject to each Board member's preference)

## **Kaufman Hall Report Conclusion**

"Lee Health is expected to continue facing systematic operational, strategic, political, and financial challenges, along with regional and local competitive pressures."

To the extent Lee Health can realize the value of prospective strategic opportunities, increase its competitive position at a level that surpasses the near-term financial impact and continue to effectively deliver on its mission, Kaufman Hall stated: "We recommend Lee Health continue with the conversion process" (p. 25).






## **Operating Margin Improves**

#### **Best Interest Determination**



## In a 9-1 vote on June 13 the Lee Health Board of Directors approved the following:

Following 10 months of diligent review consistent with its fiduciary duties to Lee Health and its mission to serve the residents of Lee County, the Lee Health Board of Directors determined that conversion is in the best interest of Lee County residents.

## Mission Agreement – Background



- Why is a Mission Agreement Needed?
- Enabling Legislation Requires Enforceable Contract:
  - "An agreement between the system board and Lee County must be completed...and include:
    - An enforceable commitment that programs and services provided by Lee Memorial Health System will continue to be provided to residents of Lee County in perpetuity so long as the succeeding nonprofit entity is in operation or, if otherwise agreed to, until the succeeding nonprofit entity has otherwise met all obligations set forth in the agreement."

## Mission Agreement – Covenants



- Mission Ensure existing programs and services continue for Lee County residents in perpetuity
- Charity Care Maintain nonprofit status and provide charity care to underserved population in Lee County consistent with similarly situated tax-exempt safety net providers in Florida
- Medicare & Medicaid Continue to participate in traditional, fee-for-service Medicare/Medicaid and maintain licenses to participate in Medicare/Medicaid
- Local Control Shall not sell, lease or transfer, directly or indirectly, all, or substantially all, of the assets or operations of Lee Health

## "Significant Reimbursement Change"



- Goal: Ensure commitment to programs and services in perpetuity while allowing Lee Health to appropriately adjust to significant changes in health care delivery and reimbursement
  - Enabling Legislation specifically allows for needed flexibility relating to the delivery of programs and services in perpetuity: "or if otherwise agreed to"
  - Last Resort: Only after all reasonable efforts have been unsuccessful in mitigating impacts
  - Difficult to define single standard to encompass all potential changes in perpetuity
    - Lee Health to present reimbursement impacts for review
    - Accounting firm jointly selected by Lee Health and County to opine as needed
  - Examples of Potential Significant Changes
    - Government moves to single payer
    - Government abolishes supplemental payment programs

## **Charity Care**



- Shared Community Objective: Maintain A Policy of Providing Charity Care to the Underserved Population in Lee County
- Measure:
  - Difficult to define single standard to encompass all potential changes in perpetuity
    - IRS requirements and considerations as non-profit provider
  - Proposed: Consistent with similarly situated tax-exempt Safety Net Providers in Florida
    - Safety Net Providers are those providers in Florida who have shown a substantial commitment to underserved populations
    - Safety Net Hospital Alliance of Florida Members: Lee Health, Tampa General, Sarasota Memorial, UF Health, Memorial Health System, Broward Health, Ascension, Nicklaus Children's, Johns Hopkins, Halifax Health, Orlando Health, Mount Sinai, Jackson Health System

## Mission Agreement – Oversight



- Shared Community Objective: Strong Lee Health = Strong Lee County
- Goal to provide oversight mechanism to assist County in carrying out enforcement of the commitments under the Mission Agreement while minimizing financial and operational burden on Lee County
- Proposed: Oversight Monitor
  - Special purpose Florida nonprofit entity contracted to provide specific functions under the Mission Agreement
  - OM Board comprised of individuals representative of Lee Health's primary service areas
  - OM may retain qualified professionals with expertise in healthcare operations, finance, accounting or related field to advise OM on compliance with covenants
  - Funded by Lee Health
  - Issues reports to County regarding oversight function

## Final Thoughts

#### The Truth



- Lee Health is not for sale
- The conversion evaluation is being conducted with full transparency
- Lee Health will be legally bound to provide safety net/charity care in perpetuity

- Lee Health liabilities will not shift to Lee County government or residents
- ✓ No taxing authority
- No financial burden on Lee County government


