We Are All Made In Your Image, Developed, All Vessels For Your Holiness And You Are With And Love Each And Every One Of Us. Whereas In 1994 It Was Impmlemented In Charlotte And Lee County In Middle And High Schools And Continues Today Operating In The Same Fashion, Student Crimestoppers And Crimestoppers Combine To Make Southwest Florida Safer Place To Live. 501 C-3 Supported By Money, Goods And Services That Enable Crimestoppers To Replenish Reward Accounts, Print, Radio



And Television Billboards, Posters And Advertising On Lee Tran Buses. Over The Past 43 Years The Tips Have Resulted In Nearly \$4 Million In Recovered Property And \$15.4 Million In Narcotics Seized. \$15.4 Million In Closure Nearly 22000 Cases To Date Cash Rewards In Excess Of \$2.3 Million Have Been Distributed And In The 43rd Year Of Partnership With The Community. Commissioner Pendergrass Was There And Offered His Support Four Our Dogfighting Community. We Look Forward To Many, Many More Years Of Working With You All. Thank You Guys So Much. [Applause]

We Have Dealt With Hurricane Irma, Covid And Ejan And No Lights In 23. It Has Been A Few Crazy Years. I Thank You All For Support Of Not Just Baseball But Football, Soccer And Everything Else. Accepting \$10,000 Donation From North Fort Meyers Civic Associations To Purchase Livestock Scale To Be Used At Lee Civic Sale Center At Ago Expo For Ffha. I Want To Share My Thanks For What You Did. This Is A Huge Donation. \$10,000. Generations Of Kids Will Appreciate Being Able To Use The Scale And Learn More About Agriculture. Commissioner, I Know That Is A Topic Near And Dear To Your Heart, Too.

Bob Hill, Board Of Directors North Fort Meyers Civic Association. I See The Work You Do. I Have Been Coming Here For Two Years. I Take Notes For My Constituents Over There. We Keep An Eye. Anyway We Appreciate Everything You All Do. Us Kids In The North Fort Myers We Need All Of The 4-H Help We Can Get. Thanks. Thanks Again. It Is A Special Day For Us. Thank You.

I Would Like To Recognize Who Is Involved In All Of These Projects In The Past Doug Muir Is Here. Nice To See You Back In The Chambers. Thank You For Your Years Of Service.

I Should Add As Well, Commissioner. I Can't Tell You How Tough That Was To Do What We Did As Commissioners To Get The Civic Center Back In The Condition It Is In. We Are Very Proud Of That. We Will Have Something Great In The Future There And It Will Continue To Be Part Of Lee County For As Long As I'm Concerned Ever. Thanks For Everyone Getting Involved To Help Youth Out There. We Were Able To Bring To The Attention We Build A Lot Of Ball Fields And Soccer Fields. We Need To Take Care Of 4-H Kids As Well. We Are Doing That. We Are Proud Of That. Further Discussions? Any Objections.

C19 Moves Unanimous 5-0. Now We Will Move On. At This Time We Will Move To Add Ministrative Agenda Item 2. Mr. Harner Please Introduce Item 2.

To Award Cdbg-Dr Funds. I Would Like In Sollier To Present The Item.

This Contains Two-Parts. First Is Your Consideration Of Awards Just Over \$229 Million Of Community Development Block Grant Disaster Recovery Funds For Public Facilities And Critical Infrastructure Projects Undertaken By The County, All Six Municipalities And School District. I Point Out There Are Nonprofits, Fire Districts, Other Independent Districts Included In This When They Have Affiliated Themselves With One Of The Sponsoring Jurisdictions. If We Could Go To The Second Slide. Second Part Staff Asks Your Direction To Prepare Some Requests That Hud Grant Additional Flexibility In Use Of The Funds Going Forward. We Talked That 70% Of The Funds Have To Be Spent For Benefit Of Low Moderate Income Households. Once You Have Awarded Housing Funds Which You Will See Later This Month, We Will Largely Have Exhausted The Low Moderate Income Projects That Have Come Before Us For Consideration. It Would Be Time Then To Request Of Hud To Drop That 70% Requirement To Lower Threshold. Typically We See Around 50%, Never Gone Lower Than That. If They Lower That Threshold You Could Use More Funds For Infrastructure And Other Projects. Secondly, We Would Ask For The Buildings For The General Conduct Of Government Waiver And Alternative Requirement. What That Means In English You Would Use These Funds On Facilities Where General Government Services Are Provided. Right Now You Can't Do That. If It Contains Any Administrative Function, It Really Renders The Project Largely Ineligible. This Waiver Would Make That Project Eligible. If You Have Questions I Will Answer Those.



Questions For Staff? Seeing None. I Call Public Comment. I Do Not See Any Cards On This. Would Anyone Want To Speak On This Item.

I Am Sorry, Mayor, I Did Miss You. Mayor Richard Johnson.

Good Morning, Commissioners. Better Late Than Never, Mike.

A Lot Of Cards Up Here.

The Community Block Grant Disaster Recovery Program, Great Program. Well-Done. Thank You, Glenn For Your Comments. That Leads Why I Want To Speak To You This Morning, Gentlemen, I Know You Have Been Throughout Lee County And Looked At Disaster After Hurricane Ian. No Other Communities Other Than Fort Myers Beach And Sanibel Were More Impacted Than Anybody Else. We Have Larger Impacts, But Devastation In Those Two Communities Was Significant. City Of Sanibel And Community Partners Applied For 14 Applications That Includes Four Public Facilities And 10 Critical Infrastructure Projects You Have Heard About. County Staff Had Numerous Applications Processed. We Want To Thank The County Staff For Work And Reviewing Funding Recommendations Today. We Know It Was Difficult. With Great Need And Applications That Exceed Available Funding. The Projects Jury Staff And Cdbg Your Committee Recommended Include Three Sanibel Projects Receiving Funding Approximately \$28 Million. We Are Grateful For Those Three Projects. They Have Been Recommended For Funding. I Am Not Here Today To Ask Any Of Those Recommendations To Change Before You. Our Community Is Asking For Your Help In That Sanibel Seeks Waiver From Hudfunding Should Additional Funding Be Available For Public Facilities In The Proper New Resilient Police Station In The Amount Of A Little Over \$13 Million. Lower Level Of Existing Station Was Completely Inundated With Floodwater. Rendering It Totally Useless. During The Time Of Recovery, Our Command Center Once We Were Able To Return To The Island, Our Command Center Was Under A Tent. It Remained That Way For Many Months. As Assistant County Manager Pointed Out, There Is A General Administrative Use For That Police Station As Well. Chief And Deputy Chief Will Be Housed In That Building. As A Result That Is The Need For The Waiver. City Sanibel In Funding Application Requested That Waiver From Hud's Determination And Can Be Granted By Hud. Report States Infrastructure Committee Met August 12. We Request Buildings For General Contact Of Government, Waiver And Alternative Requirement For Hud. I Am Here Above Today To Make Sure We Get The Sanibel Police Station Covered Under That Waiver So It Puts It In The Position For Future Funding. Thank You Very Much. I Appreciate Your Time This Morning.

Thank You, Mayor.

Would Anyone Else Like To Speak On This Item At This Time? Seeing None I Close Public Comment. Anyone To Make A Motion?

Glenn, You Heard From The Mayor Of Sanibel What You Propose On The Screen Is Something Lower Than 70% For Low To Moderate Income Waiver Waivering Would Take Care Of That Is That What Is On The Screen? That's Correct.

Gentlemen, There Is A Great Opportunity For Us To Advocate For The Unmet Need We Submitted \$9.4 Million. We Have \$1 Billion Committed I Recommend 50% For Consideration Also Waiver Is Important. Mayor Indicated Issues Having And Since It Was 11th Hour To Give Sanibel Opportunity To Deal With It. Not That I Am Advocating Advance Funds List More Comprehensive As We Get More



Funds We Have Great Availability We Did Submit Unmet Need List Which Basically Had The Projects, Didn't Have A Scoring 60, 70, 80%. Those Are The Projects The Community Thought They Met. That Would Be My Motion.

Any Further Discussion?

Glenn, When You Start Talking About Moving Numbers Around. In Defense To The Community, How Long Will It Take To Get To That? From Timing To Plan Accordingly If This Moves Forward?

Great Question, Commissioner I'm Not Sure I Have A Good Timeline. Board Submitted Waiver Request To Hud To Harden Hertz An Arena. In Beginning Of May We Talked Two Months Before We Submitted It. It Is Pending. I Didn't Expect These Waivers Would Take As Long. I'm Not Sure.

I Am Helping The Community Anticipate What Could Be Coming And When.

Yes, Sir.

Commissioner Hamman.

Mr. Harner, Do We Want To Reach Out To Our Federal Delegation, Senator Rick Scott, Congressman Donald And Congressman So We As Well For Both Waivers.

Absolutely. We Very, Very Not Talked About The Second One But We Certainly Can.

Try To Engage Everybody Who Could Help Us. These Waivers Make Sense. We Are Going To Do Tremendous Amount Of Housing As Part Of \$1.1 Billion. You Highlighted Unmet Need Also Highlighted By Mayor Of Sanibel. They May Not Meet Low To Moderate Income Household They Had The Most Damage In The Community They Deserve The Dollars To Help Rebuild What Was Lost In Their Community.

I Support The Motion. We All Know For Every Action Is Reaction. Change In Threshold Would Affect Other This Is Line For Money? Cut Money From Other Entities. Only So Much Money. Will This Change That.

What This Could Potentially Change Is The Amount Of Funding That You Currently Have In Reserve For Additional Affordable Housing Development. Right Now There Is \$200 Million Pending That You Will See Later This Month For Award. There Is Another \$150 Million Behind Be That. In Talking To Developers In The Community There Is Some Concern Flooding The Market With This Many Tax Credit Deals At One Time Might Impact Value Of Tax Credits The Developers Are Using To Deliver This Housing. We Need To Have A Conversation With The Board About How Much Of That Reserve Housing Funding Might Be Redirected Elsewhere To Include Infrastructure. I Hope That Answers Your Question. It Doesn't Affect Anything Until The Board Makes Some Future Decisions. Thank You. Any Further Discussion? Commissioner Ruane Has Motion On The Floor. Second Commissioner Hamman. Any Objections? No Objections. Item Moves 5-0 Unanimous. Please Introduce Item 3.

Thank You. This Is To Authorize Chief Hearing Examiner's Annual Merit Increase.

At This Time I Am Going To Begin Discussing The Item. I Will Be Abstaining From Vote Due To Pending Land Use Case. I Will File The Form 8b With The Clerk. Vice Chair Ruane Would You Please Take Over At This Point And Let Me Know When The Voting Is Complete.

We Are Going To Introduce The Hearing Examer's Annual Increase Who Is Introducing That.

If I Can Be Of Assistance. Contractually And Annually The Board Is Obligated To Consider A Merit Increase For The Hearing Officer. One Of Your Four Contract Employees. Pursuant To Her Employment Agreement As With Your Other Three Contractual Employees The Range Of Her Merit Increase Would Be Between 4 To 6%. Given Evaluations In Your Material And Part Of The Public Record I Would Request A Motion With A Specific Percentage Amount Included.

Motion To Approve The Contract With 6% Increase Based Upon Evaluations And That Is What We Do For General Employees Also.

Would You Tell Commissioner Greenwell He Can Come Back In.

Mr. Harner, Item 4.

This Is To Award Contract To Construct Lake Walks Water Improvements Phase 3. Mr. At To Lean Me To Present.

Natural Resources. This Award Contract To Higgins For \$4.3 Million For Construction Of The Allen Injection Facility For West Lake And Lakes Park. We Have Tmdl For Hendry Creek For Reducing Total Nitrogen. I'm Here For Any Questions You May Have.

Out Of Curiosity, How Will We Do You Have A Measuring Point How To Measure The Water Flowing Out Of The Park To The Creek To Show Actual Reduction?

We Brought A Consultant On Board To Test This Technology. They Have To Get Ph Right And Certain Doses Of Al Lum Reduction. They Take Water Quality Before The Work And After The Treatment Is Done. It Will Require Some Low Dosing Of Al Lum Throughout The Year To Keep Clarity And Reduction Of Nitrogen And Reduce Phosphorus As Well To Make That West Lake Clean.

You Will Test A Couple Times Throughout The Year To Ensure This Is Doing What It Is To Do?

Absolutely. That Is Part Of The Operating Plan For The Project.

Good Morning. Amanda Swindle. First Public Hearing Legally Advertised. This Public Hearing Is To Certify The Special Assessment Role For The Fiscal Year 2025 Solid Waste Special Assessment To Implement Rates Approved On August 6. Staff Is Here If Up Any Questions.

Questions For Staff At This Time.

No Questions. Call For Public Comment. Anyone Wish To Speak On Item 1? Seeing None Close Public Comment.

Move The Item.

Motion From Pendergrass. Second From Hamman. Further Discussion? Objections? Item 1 Moves Unanimous 5-0. Now We Will Move Back To Item 1 On Administrative Agenda. Please Introduce Item 1 Of Administrative Agenda.

Item 1 Proposed Resolution That You Directed Our Office To Prepare And Present To You For Consideration. The Amendment Text Would Serve To Express The Board's Opposition To Proposed Constitutional Amendment 4 Which Will Appear To The General Election Ballot November 5. If I Could Engage In A Quick Discussion. I Have Heard Comments That The Argument Is Board Is Without Authority To Express Its Opinion Beyond The Scope Of Your Charter. I Would Point Out That Argument Fails For Two Reasons. One Those Advancing That Argument Are Trying To Make Supremacy Clause Argument. By That I Mean Our Charter Contains Language Which Speaks To It Cannot Conflict Or Supersede State Constitution Or State Law. We Know That To Be True. That Is A Statement In Our Charter, However More Importantly A Statement Contained In Florida Law. More Importantly, Perhaps, For The Purpose Of This Discussion The Resolution That You Have Before You Is Just That. It Is A Resolution. Not An Ordinance. The Board By Its Action Today Is Not Mandating Or Prohibiting Any Type Of Conduct. Merely An Expression Of The Board's View On Proposed Constitutional Amendment. It Is Our Office's Opinion You Are Well With In Your Authority To Approve Or Not Approve As The Board Sees Fit As The Representatives Of The People Of Lee County. With That If You Have Any Further Questions Of Our Office We Would Be Happy To Advise. If Not Given The Board's Previously Instituted Directions We Respectfully Request Approval.

Any Questions Or Statements For Staff At This Time? Seeing None. I Will Call For Public Comment At This Time. I Have A Lot Of Cards. We Expect A Certain Amount Of Quorum. Everyone Will Get Three Minutes. When The Light The Orange You Have One Minute. When It Is Red You Are Done. I Do Not Like To Cut People Off But Unfortunately I Will. We Have So Many Cards Everybody Gets Same Amount Of Time. I Would Address The Fact We Expect Quorum And Respect. Don't Boo, His, Clap.



Let Everyone Speak. Please Address The Board As The Board Not Individuals. Nope Attacks, Your Type To Speak And Please Do. Remember We Are Going To Listen. We Will All Show Respect Today. I Appreciate That. We Will Start Off With State Representative Jenna Persons Malia. Good Morning.

Good Morning, Mr. Chair, Commissioners. For The Record. Jenna Persons Melca State Representative House District 78 And We Have Sennor Jonathan Martin As Well. Thank You For Bringing Forward This Resolution For Consideration We Respectfully Ask You Adopt This Resolution Today. It Is Important To Bring Awareness To This Deceptive And Extreme Amendment That Is Amendment 4. When The Voters Of Lee County And A Crop The State Do Research, Read 34 Words. Why Are There No Definitions? Do The Words Mean? Read Financial Impact Statement. I Am Confident When You Do Research Vote No. You Should Vote No On 4. If You Believe An Abortion Should Be Performed By Licensed Doctor Vote No On 4. The Florida Division Of Elections Does Not Agree With Your Interpretation Of Amendment 4 As Present Understand The Resolution. There Are Other Sections Of State Statutes To Protect Citizens. First, Florida 390-Point 01114 Recognizes Physicians To Obtain Written Consent From Parent Before Performing Abortion On Minor. Second 390.0111.2 Allows Only Licensed Physicians Igs To Perform Abortions. Misleading To State It Would Strike Already Enacted Protections Instituted By The State Of Florida By Broadening The Definition Of Healthcare Provider To Those Not Medically Licensed. It Is The State That Healthcare Providers Do Not Have To Be Licensed That Is Made Up. This Resolution Is Based On What Ifs And Pure Speculation About Lawsuits And Future Court Decisions. Gentlemen, I Had The Honor Of Opening Up This Session With Invocation From Jewish Tradition. As Jewish --

I'm Sorry. Please Start Over. Gentleman, I Had The Honor Of Opening Up This Session With Invocation From The Jewish Tradition. It Is As Jewish Clergy Rabbi That I Speak To You Now Urging You To Vote No On This Resolution. In Judaism Full Access To Save And Legal Abortion Is Healthcare. Jewish Law Not Only Permits Abortion In Many Cases But Also Requires It When The Life Of The Pregnant Individual Is At Risk, Both Physically And At Times Psychologically. Life Does Not Begin At Conception Under Jewish Law. It Does Not Consider A Fetus To Be A Full Being With Soul Until It Is Born. This Comes From The Story Of Creation In Genesis When Life Begins With Breath. Genesis 2:7. God Blew The Breath Of Life And The Human Became A Living Being. In Jewish Law First 40 Days From Conception, Fetus Is Mere Fluid. This Would Correspond To The First 7-8 Weeks Of Pregnancy. Fetus Is Considered Water. Following This The Fetus Is A Physical Part Of Pregnant Individual's Body. Fetus Is Not Viewed As Separate From A Woman's Body Until The Onset Of Labor And Childbirth. I Understand Other Religions Have Different Understandings Of Personhood When Life Begins. United States Constitution Supports Freedom Of Religion And Demands No One Imposes A Single Religious Viewpoint On All. Laws And Regulations Limiting Access To Abortion Are At Odds With Our Nation's Founding Principle Of Religious Liberty. Judaism Full Access To Safe And Legal Abortion Is Healthcare. I Urge Against This Resolution And Let Pregnant Individuals Make These Decisions With Guidance From Physicians In Their Own Religious Traditions.

I Would Like To Acknowledge The Fact That The Legal Advisor Did Mention That It Is Very Appropriate To Use Your Public Office To Inform And Edify The Public About Issues Of Importance. I Thank You All For That. I Would Like To Note On February 10, 2024. The Republican Party Of Florida Passed Resolution That Gave Recommendations And Guidance On All Six Amendments. It Is Incumbent To Have Those In Elected Office Be Aware And Guide And Give Information To The Public To Help Them Become Informed. It Is My Personal Opinion That Even People That Are Pro-Choice Should Find This Amendment Objectionable Because Of The Number Of Reasons That Have Already Been Mentioned. The Least Of Which Is The Fact That Something I Have Mentioned Previously. Our Constitution Here In The State Of Florida Is 74 Pages Long Depending Upon What Font You Use. Including Protections For Suckling Pigs And Safeguards That Were Instituted For Greyhound Racing Dogs Because They Might Be Abused. Statutes In The United States Protect Eggs Of The Eagles And Yet Here We Are Talking About Abortion Of Unborn Children. Constitutions Are Supposed To Be Drafted Specifically To Define A Limited Specific Focus And Function Of Our Government. It Is Not Intended To Be Used As Catch All Free-For-All In Order To Lock People In When Legislation Can Be Done Instead. Legislation Is Supposed To Be Done By Our Legislators Duly Elected Psychological Basis To Have The Laws Wax And Wane With The Populous. I Encourage Commission To Approve The Proposed Resolution. Is This Not A Situation That Was Detrimental To My Health, Mentality If Not Physically? I Would Like To Add One More Thing. It Is On Here And I Thank You To The Rabbi For Proceeding Me. I Am Jewish. I Will Repeat The Torah, Rabbi Sources Consider The Women's Physical And Emotional Health Before That Of The Fetus. Judaism Considers The Fetus To Be Part Of The Woman's Body. Gentlemen For The Record Gale Markham. Cpa, Florida Native, Lee County Resident 50 Years. Registered Republican At That. My Story Is Not Pretty. It Is Hard For Me To Tell You My Story. It Is Still 73 Years Old Still Very Emotional. My Childhood Was Ugly. I Am Victim Of Incest. My Father Sexually Abused Me From The Time I Was 4 Years Old Until I Was 14 When My Parents Finally Divorced And We Were Able To Escape His Rath. I Am A Very Salient Individual. I Made A Point Of Not Living That Life As An Adult. I Sought And Received Full Scholarships To Go Off The University



Of Florida And Never Looked Back. I Have Had A Very Successful Life And A Happy Life Because I Chose Not To Live My Life As A Victim. As Part Of That Success I Have Made A Great Deal Of Effort To Give Back To This Community. I Founded The Pace Center For Girls Almost 18 Years Ago. Those Are Girls From 11 To 18 Years Old That Have All Been Abused, Abandoned Or Neglected. Their Stories Are Very Much Like My. It Is Interesting I Was Able To Do That Because I Healed So Much From That, What I Found Is I Was Not Alone There, There Are Many Of Us, We Don't Talk About It, We Are Full Of Shame. It Is A Family Secret Is The Way It Was Treated In My Family. What I Found These Girls Are Victimized Bisexual Abuse. In Fact We Have Had Over 1,000 Girls Go Through Pace Right Here In Lee County. Just This Year We Have Had Over 100 Girls Enrolled. 38% Of These Girls Have Admitted To Being Sexually Abused Right Here In Lee County This Year. It Is Not Going Away. We Need To Address That. What I Am Asking You To Do Is To Remember A Few Things. One, If I Were To Become Impregnated By My Father When I Was 12 Years Old. I Am Not Sure I Would Have Known What A Pregnancy Would Be In My Body Carries A Baby At Six Weeks. My Father Threatened To Kill Me If I Ever Told Anybody. I Couldn't Even Go To Tell Somebody And Get Help. If I Was Carrying This Baby At 12 Weeks Under The Proposed The Way It Is Now, I Could Even Get An Abortion Or Would I Have A Life Time Sentence Of Carrying My Father's Child? I Wouldn't Have The Life I Have Right Now If That Would Have Happened To Me. Thank You Very Much. Please Stay Out Of This. It Is Our Business. Let The Voters Decide.

Hello Commissioners. I Live Here In Fort Myers. I Am Retired Now. For 35 Years I Practiced Medicine In Lee County. I Oppose Amendment 4 And Grateful For Your Proposing This Resolution To Also Oppose Amendment 4. I Think You Correctly Pointed Out The Language Is Vague And Deceptive. It Would Most Certainly Lead To More Late-Term Abortions. I Think No Matter What Side Of The Debate You Are On Or What Your Religious Affiliation Is Or Idea Of Personhood Is, I Think The Vast Majority Of Us Really Cringe At The Idea Of A Late Term Painful Abortion. I Think We All Cringe At The Idea Of Lack Of Formal Parental Consent If Our Teenage Daughters Seek An Abortion. These Are Grave Injustices And These Will Be Made Worse If This Amendment Passes. Thank You.

Guy Matthew From Estero. Honored And Feel Privileged To Speak To You Today. Thank You For The Opportunity. I Come As Confused Old Man To Talk To You Because Saturday There Was A Letter In The Editor To The Newspaper And Also Someone Mentioned Today. It Is Over Reach For The Commission To Speak On This Issue. They Want To Suppress Your Informed Decision And Council. Yet Several Weeks Ago The Board Was Asked To Make A Decision To Contemplate The Future Of The Lee Health System. Is That Not Healthcare? Don't You Have Some Responsibility For Healthcare In Lee County? They Want To Suppress Your Voice To Speak But Yet Accept 10s Of Millions Of Dollars From Out Of State People To Influence Our Constitution. Many People From Out Of State Are Contributing \$5 Million A Pop. They Will Have More Influence Than You If You Remain Silent. Also, They Said The Current Law Requires A Physician. The Proposed Amendment Specifically States There Shall Be No Law That Restricts. That Eliminates Any Attempt To Enforce The Current Statutes. The Current Law Will Have To Conform To The Constitution. The Commissioners Responsibilities Do Not Include Supporting Political Agenda Of A Small Group Of Local People. Let The Voters Determine The Result. Do Not Interfere With Democratic Process. Your Role Is To Protect Our Right To Voice Opinions And Vote On Issues, Not Restrict Us. Thank You.

Good Morning, Commissioners. Debby Healey. Lee County Resident. Thank You From The Bottom Of My Heart For Your Patience Dealing With This Resolution. I Hope You Hear From My Heart How I Feel. I Am A Registered Nurse. We Ask You To Support The Resolution Recommending No Amendment 4. Over The Past Several Weeks You Heard The Trauma, Emotional Distress, Tragedy That Women, Girls, Daughters And Even The Expecttant Fathers Have Gone Through At The Risk Of Abortion. It Does Not Bind Anyone To Prevent Them From Voting One Way Or The Other On The Issue. I Don't Think It Influences That Much In Any Way As To Whether If I In My Instance The Way Amendment 4 Is Written Is Horrible. For All Of The Points Raised. I Don't Need To Repeat It. I Was Notified. I Had No Used. Struggling To Pay Rent Familiar Working Three Jobs To Keep A Roof Over My Head And Lights On. At Four Weeks I Faced Keeping The Baby Or Terminating The Pregnancy. After Consulting The Nurse Care Practitioner As Well As Being Psychoanalyzed By My Therapist And Psychiatrists. The Risks To My Health Were Too Severe To Carry Pregnancy. I Have Polyps And Rare Conditions In Ovaries That Resulted In Me Having Hysterectomy. My Baby Died. The Blood Occurred. Waiting To Decide What I Should Do Was Gruesome. Pulling Babies Out Of Bodies. What About My Baby Fulling Out Of Mine Taking Away Choice? I Want To Talk About How You Should Stay Out Of This And Not Oppose Amendment 4. People Should Have Right To Know What Is Best For Them. What Was Best For Me Was Terminate Pregnancy. I Was Going To Keep It. Choice Was Taken Out Of My Hands. Doctors Knew Best. My Healthcare Provider Knew What Was Best For Me. I Wasn't Able To Carry That Baby To Term. Training They Received Was Enough To Let Them Know That Baby Would Not Have Made It. Would Have Been Severely Deformed If Born. I Urge You To Respect People's Healthcare Providers, None Of You Have Medical Degrees, All Of You Have Very, Very Good For The Community In Making Decisions As Well As Land Care. I Appreciate You Are Cleaning Up Lakes Park Annual Environment. Trust Doctors To Make Decisions For Patients. Man I Became Pregnant With Was Not Going To Help Me. I Was Going To Be By Myself Single Mother Starting Nursing School With Baby Severely Deformed. What About The Fact I Would Have Been Financially Responsible? Think About That And Trust Doctors And People To Make Their Own Decisions. I Oppose Your Resolution Opposing Amendment 4. Thank You To Are Your Time.

Who Else Would Like To Speak? I Am Alexa. I Came Before You To Oppose Amendment 4. I Came Before You Today To Propose More Than What I Have Seen This Morning. That Is A Lack Of Facts. I Bring You Couple Tidbits From The Peer Research. First Question When During Pregnancy Do Most Abortions Co-Cur. They Occur During First Trimester Of Pregnancy. 2021, 93% Abortions Occurred First Trimester At Or Before 13 Weeks Of Gestation. Gestation Nobody Knows Exactly When It Occurs When Guess Station Starts. According To Cdc 6% Between 14 And 20 Weeks. 1% At 21 Weeks Or More Gestation. Cdc Figures Include 40 States And New York City Not Entire State Of New York. The Institute Estimates 2023 Medication Was Used For Almost Two-Thirds Of All Abortions. Dilation And Evacuation Procedures Account For Less Than 1% Of All Abortions Performed In United States According To The Cdc. I Think Additional Meddling With Unnecessary When Considering How Near And Possible Basic Medicative Abortion Access Is To Obtain In States Like Florida Where After Six Weeks They Shut The Door On Your Life. When You Stand Before God, Do You Want To Say I Did All I Could To Protect Children Or Would You Give The Same Excuses We Heard Today. One More Thing I Heard Ignorantly Stated "The Bible" Exodus 21:25. If A Man Accidentally Strikes A Pregnanbt Woman Wile Fighting With Another Man, And The Womans Children Come Out, He Man Who Struck Her Must Pay A Fine If There Is No Harm. If There Is Harm, The Punishment Is To Match The Injury. He Shall Pay As The Judge Is Determined. Life For Life, Eye For Eye, Tooth For Tooth, Hand For Hand, Foot For Foot, Burn For Burn, Wound For Wound And Stripe For Stripe.

I Don't See Anyone Else To Speak. Anyone Else? I Will Close Public Comment. I Will Bring It Back To The Board. Before I Do So I Would Like To Mention We Listen To Everyone. We Were Quiet. We Were Respectful. Now We Are Going To Obviously Have A Decision To Make. Please Show Us The Same Respect. No Matter What Happens Here I Would Appreciate If No One Reacts. These Are Tough Decisions. We Have Listened For Three Different Board Meetings. I Felt Like It Was Very Important We Heard All Sides And I Think We Have. I Would Like To Bring It Back To The Board For Discussion. Would Anyone Like To Open Discussion? I Will Open Discussion. The Resolution Today Before Us Today Is Intended To Oppose Language In Amendment 4. Because It Is Very Vague. I



Encourage All Of Us To Read The Amendment Carefully. This Resolution Does Not Change Anyone's Ability To Vote. It Would Be A Resolution Saying Please Read It. Please Look At It. I Think The Language Is Vague For A Reason. I Would Not Consider Myself A Leader If I Didn't Stand Up And Realize And Read The Resolution And Say There Is Something Wrong Here. I Think It Is Important That We Bring That Up. That Is My Discussion Part Of It. I Wanted Everyone To Have Ability To Speak. It Is A Hot Subject. There Is No Right Answer. We Are Divided Country. We Should Always Understand We Can Help The Unborn. How Can We Do That? Read It Carefully. Everyone. This Is Not Restricting Anyone's Ability To Vote. When People Say That, That Is Not True. That Is What I Would Like To Say. Would Anyone Else Like To Comment On The Board? I Will Make A Comment, Mr. Chairman. Thank You Very Much. Some Of The Speakers And Stories Today Were Gut-Wrenching, Heart Breaking Stories That We Got A Chance To Hear Today. While Many Were Speaking I Said A Prayer For Them For Healing For Them. I Wish That The One Thing I Could Convey Is Compassion And Love And Empathy And Respect For People Who I May Disagree With On This Issue. The Greatest Commandment And We Heard A Lot Of Bible Love The Lord Your God With All Your Heart. Mind, Soul And Strength. Second Greatest Is Love Neighbor As Yourself. Love God And Love People. I Just Want People To Know Even If I Disagree With You On This Issue, It Doesn't Mean I Don't Love You Or I Am Hateful. People Who Believe In God Are Not Fringe Extremists, Not Deplorables, Not Weird. We Are Great People Who Would Stop And Help You If You Were On The Side And The Road And Needed Help. I Agree With You, Mr. Chairman, This Language I Believe Is Very Broad, Open To Interpretation, Misleading. I Don't Think -- I Think Voters Need To Be Aware This Is Something That Deserves A Second Look. I Will Support That Motion When It Is Made.

Anyone Else? Commissioner Ruane.

Thank You. Appreciate Our County Attorney Bringing This To Our Forefront. I Was Asked On Saturday.

Have A Great Day, Sir.

I Was Asked On Saturday Why Is This Before Us? Is It Right Or Wrong? In My 18 Years In The Government The Constituent Voices Speak As Loudly As They Have. This Issue Has Come Out Loudly And Clearly. I Don't Get To Choose The Votes I Make. I Have To Make Them Regardless. I Have To Suppress My Personal Feelings In This Issue. I Listen To The Majority Of People Here And E-Mails We Read, Answered Every Single One. We Have Dealt With Them. I Agree With The Two Commissioners. I Feel That Constituent Indicated What Their Believe Is Whether You Agree Or Disagree. Think Through The Processes. I Have Seen A Lot Of Emotional Speakers And Excused Some Emotion That Threatens If I Don't Vote This Particular Way Vote Me Out Of Office. That Is Your Prerogative. Every Day That Is What I Do. If This Vote Changes Your Mind So Be It. It Is My Responsibility To Vote This Way. It Is The Constituents That Asked Us To Do So And They Have Been Here Three Or Four Meetings. In The Last Four Years I Haven't Seen That Engagement With Constituents On Many Issues. I Do Think Is Language Is Too Vague, This Is Something We Have A Right As Resolution To Put Forward. As Everyone Indicated It Is Something Opposing The Vagueness In The Wording. Those Are My Comments.

Those People To Vote For Us Left The Room. The Elephant In The Room. We Are Here Today Because Dnc Decided To Challenge Statement Of Florida Because Of The Legislation. This Is Now In



Our Lap Because The State Made Decisions. They Had Desantis Or Another Resident Running For President They Need To Push Polls To Drive People To Vote This Year. This Is What They Use Emotional Issue. We Had This Discussion At The End Of The Day We Don't Want This Discussion With Our Neighbors. They Have To Because They Made This Issue To Bring People To The Polls. Very Vague Issues With Funding To The County If It Is Passed. The Dnc Know It Will Be Challenged. The Goal Is To Drive People To The Polls For Presidential Election. I Disagree I Understand Why We Are Here. I Support My Colleagues On This.

#### Commissioner Sandelli.

Very Personal And Strong Opinions On Both Sides. It Is Clearly Communicated To The Board. In The End This Will Be Decided Boy All Of Us At Election Time. Personally I Am Pro-Life. When I Cast My Individual Vote In November I Will Do So Accordingly. I Trust And Honor My Position As I Will Honor Yours. I Was Taken Back When The Board Was Asked To Be Involved In This. My Constituency Is All Of Lee County. Yes Vote Or No Vote. Again, Final Decision Will Come From All Who Will Vote In November As It Should Be. We Should Be Carefully Studying The Topic, Helping Inform People, Trusting Our Own Beliefs And Vote Accordingly As We See Fit. My Feeling Is That I Would Not Adopt The Resolution As It Stands.

That I Will Make My Last Comment Unless Commissioners Want To Add To That. My Comment Is This Shows How Voting Goes. Everyone Has A Right To Their Opinion. Everyone Has A Right To Make A Vote. That Is What Happened Here Today. Even With This Board. That Being Said I Will Ask Does Anyone Want To Make A Motion?

In My Private Capacity. Not In This One. I Would Like To Raise I Am Sure You Came With The Concerns Regarding Supervisor Of Elections Tommy Doyle. Efforts Have Been Made To Reach Out To Cord Bird For Input. The Word We Got Back Was It Is A County Matter, County Financial Matter, Something That Needs To Be Addressed Here. It Has Nothing To Do With Election Integrity. I Don't Know What If Anything The Board Can Do Or Consider But My Concern As Private Citizen Is That Forget The Salacious Aspect Of It. That Is Not What I'm Talking About. My Concern Is There Are At Least Allegations Raised And Concerns Brought To Light That County Money That Was Used Or Money That Was Supposed To Be Used Through The Supervisor Of Elections Office May Have Been Miss Appropriated Either Because Of Time Spent On The Job Doing Activities Not Work Related And/Or Settlement Agreement That Was Maybe Using Moneys Inappropriately. I Would Like The Commission To Please Look Into Whether This Is Something That Falls Within Your Purview And If So My Recommendation Would Be If You Have The Authority To Do So Maybe Put Some Leverage For Lack Of Better Description If You Don't Have That Authority Upon The Powers That Be To Be Able To Have An Audit Done Of The Finances Through The Supervisor Of Elections Office And Have Law Enforcement Look To See If There Is Any Criminal Intent. Leaving It Vague And Undefined Without Decision Is Not In Best Interest Of Lee County. I Am Not Saying Anything Is Inappropriate Being Done. Joyce Campana. I Have A Card Up There, Too. Since You Just Passed The Resolution Opposed Amendment 4 I Am Asking The Board To Passion Resolution In Favor Of Adult Personal Use Of Marijuana Known As Amendment 3 To Allow Anyone Over 21 To Use And Possess Up To 3 Ounces Marijuana Fiscal And Personal Health Issues For Supporting. I Understand Budget Hearing First Today. This Is Right Up Your Alley. Florida Division Of Elections Estimates Increase In State Tax Annually Ranging From Low Of \$195.6 Million To \$431.3 Million. Not Including The Possible Enactment Of Excise Tax. The Start-Up Costs Of Approximately \$20 Million Would Be Covered By The Revenue Generated During The First Year. Revenues From Amendment 3 Would Generate More Revenues Than Source Like Tolls Identified In Your Commissioners 23-24 Strategic Priorities.



Passage Of Amendment 3 May Lead To A Boost In Tourism Dollars. Job Generation And Those Numbers Are Based On What Is Seen In Other States. Job Generation And Less Prison Crowding Were Identified In Those Other States As Cost Savings. Legislation Would Allow Law Enforcement To Direct Efforts To More Severe And Heinous Crimes. In Terms Of Jobs Amendment 3 Would Directly Benefit Existing Florida Business. Local Grower Of Marijuana. Generate Paying Jobs. We Know Florida Has Medical Marijuana Use This Is For Personal Use To Relieve Pain Depression Anxiety And Stress As Alternative To Alcohol To Promote Joy And Relaxation. Passage Of Amendment 3 Means Public Spaces Will Remain Smoke Free There Are Laws To Allow Regulation Like Tobacco. Existing Laws Enforce Smoking In The Undesignated Areas. 15 Florida Counties And Cities De Criminalized Marijuana Based On Benefits In Other States Revenues And Tourism Dollars And Health And Well-Being Of Citizens Of Lee County Resident The. I Ask You To Prepare Resolution For The September 17 Board Meeting. The Precedent By Pressing Amendment 4 Is Requested By Another Group Mandates You Respond To Constituents Supporting This Amendment.
