

RESOLUTION #18-11-02

Amending the General Fund #00100 budget to incorporate the unanticipated receipts into Estimated Revenues and Appropriations for the fiscal year 2018-2019.

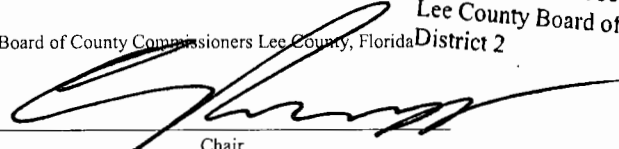

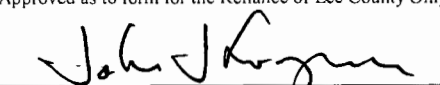
