2. The said District in carrying out the purpose of this Certificate shall have free right to run the streets of Lee County with its vehicles, subject only to State regulations incident thereto as may govern ambulances and shall have free access to and the right, within said area, to perform (ALS) non-transport service; provided, however, the District Shall at all times, to the extent permitted by law, hold Lee County harmless, release and indemnify County from any loss or damage by reason of the acts of District, its agent, servants, or employees. The District nor Lee County waives their right to sovereign immunity and this Hold Harmless and Indemnity Agreement is limited to the amount waived under Section 768.28, Florida Statutes.

3. It shall be the duty of said District, upon the acceptance of the terms of this Certificate, to diligently and efficiently protect and save lives and authority is hereby granted to said District to do all things needful to such ends not inconsistent to Florida Law now in existence or which may change or hereafter be passed. District certifies it has the legal capacity to operate said (ALS) non-transport services and to comply with the Laws of Florida, particularly Chapter 40 et al. Florida Statues.

4. In no event shall Lee County be responsible in any way for the debts or obligations of the Fire District contracted in the duties imposed under this Certificate nor shall the County be liable in any manner whatsoever on account of the negligence of said District in carrying out the provisions of this Certificate.

5. Upon the failure of said Fire District to carry out and fulfill the obligation and duties hereby imposed upon it, all the rights hereby granted to said District shall thereupon be forfeited.

6. This Certificate shall be in force and become effective upon written acceptance of its term by said Association being filed with the County Clerk.

7. The permit is valid for the period January 31, 2019 to January 31, 2021 unless sooner forfeited or rescinded.

Bonita Springs Fire Control and Rescue District will provide basic and advanced life support care in concurrence with Less County EMS transport services. Once Lee County EMS arrived on scene, Bonita Springs Fire Control and Rescue District personnel will continue to assist Lee County EMS personnel with patient care and preparing the patient for transport.

- 2. The effect of the proposed service on existing services with respect to quality of service and level of care. Bonita Springs Fire Control and Rescue District will provide the same quality of service and level of care as specified in the Lee County Common Treatment Guidelines.
- 3. The effect of the proposed service on the overall level of out-of-hospital medical care in the County. Bonita Springs Fire Control and Rescue District will provide early access to basic and advanced life support care to individuals who activate 911 for medical emergencies.
- 4. The effect of the proposed service on existing hospitals and other health care facilities. Bonita Springs Fire Control and Rescue District will have little to no effect on existing hospitals, but other health care facilities will benefit from early access to basic and advanced life support care while waiting for transport services.
- B. That the applicant has sufficient knowledge and experience to properly operate the proposed service as evidenced in Section Six (A).

Bonita Springs Fire Control and Rescue District has been providing ALS non-transport services for more than 20 years. All paramedics are trained and credentialed by the Medical Director in accordance with the Lee County Common Treatment Guidelines.

- C. That the applicant has an adequate revenue base for the proposed service and the proposed service will have sufficient personnel and equipment to adequately cover the proposed service area. Bonita Springs Fire control and Rescue District has demonstrated the commitment to providing pre-hospital care by ensuring sufficient personnel and equipment and allocating sufficient funding to support the services provided.
- D. The proposed service meets the minimum equipment requirements on a BLS transport or ALS permitted emergency vehicles as set forth in ch. 64E-2, Florida Administrative Code, ch. 401, Florida Statutes, and additional equipment or personnel as required in the Lee County EMS Common Treatment Guidelines.
