RESOLUTION TO CONVEY COUNTY REAL PROPERTY TO THE CITY OF FORT MYERS PURSUANT TO SECTION 197.592(3), FLORIDA STATUTES

WHEREAS, The Board of County Commissioners is the governing body for Lee County, a political subdivision of the State of Florida; and

WHEREAS, The Board of County Commissioners has certain powers and authority relative to the disposition of real property belonging to the County; and,

WHEREAS, Section 197.592(3), Florida Statutes, provides that certain lands acquired by the County for delinquent taxes, which are located within the boundaries of an incorporated municipality of the County, shall be conveyed to the governing board of the municipality in which the land is located; and,

WHEREAS, The City of Fort Myers has been notified these properties received by the County through the process of escheatment (non-payment of taxes) located within the boundaries of the City of Fort Myers, all being in Fort Myers, Florida, 33916; and,

WHEREAS, The Board has determined that these properties are not needed for any County purpose, and further finds that the conveyance of such properties to the City of Fort Myers serves a public purpose and is in the public interest; and,

WHEREAS, it is the intent of this resolution to follow requirements of Florida Statute 197.592(3).

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS THAT:

- 1. The above recitations are true and accurate and are hereby adopted and incorporated herein as if set out at length.
- 2. Lee County has concluded that the real property described below is not needed for County purposes. This real property is particularly described as follows:

- 3. In accordance with section 197.592(3), Florida Statutes, the County agrees to convey by donation the properties as described above to the City of Fort Myers.
- 4. In order that the proposed transaction is more efficiently consummated, the Board specifically authorizes County staff to finalize all necessary documents to complete the conveyance of the property described in this Resolution. In addition, this Resolution specifically authorizes the Chairman of the Board of County Commissioners to execute any documents necessary to convey the property to the City of Fort Myers.
- 5. This Resolution shall become effective immediately upon its adoption.
