

**AGREEMENT  
CONCERNING THE USE OF LEE COUNTY BOARD OF COUNTY COMMISSIONERS  
ADVANCED LIFE SUPPORT TRANSPORT LICENSE**

This agreement is entered into this 3<sup>rd</sup> day of July, 2019 by and between CITY OF FORT MYERS, a municipality incorporated in the State of Florida, hereinafter the "City", and the Board of County Commissioners of Lee County, Florida, a political subdivision of the State of Florida, hereinafter the "County".

NOW, THEREFORE, it is mutually agreed between the Parties as follows:

1. The County possesses and maintains an Advanced Life Support Transport License (License). The City provides Emergency Medical Services within the City boundaries under the County's License. This Agreement shall be limited to the conditions for which the City will obtain consent for grant applications and proposed changes to the existing use of the County's License.
2. The County consents to the City's use of the County's License solely for the submission and receipt of the Overdose Prevention in States (OPIS) Cooperative Agreement Grant. The County will also allow the City, as a sub-agency under the County's license within the EMSTARS system, to establish and/or enhance an electronic EMS data collection system to enable submission of EMS incident related data in compliance with the Florida Data Dictionary V3.4.
3. The City will obtain consent from the County's Director of Public Safety prior to applying for any grants from the Florida Department of Health Bureau of Emergency Medical Oversight. Consent shall not be unreasonable withheld by the County's Director of Public Safety.
4. The City will provide written notice to the County 30 days prior to any application for a Certificate of Public Convenience and Necessity (COPCN).

5. This agreement contains the entire agreement between the parties hereto and there are no promises, agreements, conditions, representations, oral or written, express or implied, between them except as set forth herein.
6. No change or modification to this agreement shall be effective unless the same is in writing and signed by both parties hereto.

IN WITNESS THEREOF, the County caused this Agreement to be executed by the Chairman of the Board of County Commissioners and the City has caused this Agreement to be executed by the Mayor of City of Fort Myers, Florida. Said Agreement to become effective and operative with the fixing of the last signature hereto.
